- Theresa Perry provided an update on the partnership for the depot: The mission of the depot is to connect river, town, and lake. Partners include State Parks, Cascade Chamber, and the Southern Valley County Recreation District; This partnership started in 2011. Over the last four years, average daily contact is as follows:
- 2014: 24 people
- 2015: 25 people
- 2016: 26 people
- 2017: 26 people
- 2017 saw a total of 1,242 visitors. They depot was open 9 days in June, 18 days in July, 17 days in August, and 3 days in September. These numbers do not include the eclipse, that day alone saw appx. 1,500 people. There was a total of 296 hours worked which resulted in a total of $\$ 3,287.59$ paid in wages. The Cascade Chamber portion of the bill is $\$ 821.89$. A motion was previously made to pay the cost - as treasurer, Scotty accepted the bill.
- We welcomed Victor and Carrie Kranz with Lake Cascade Sport and Marine as well as James Bergquist with FIG (Financial Insurance Group) as new members. Lake Cascade Sport and Marine should be opening this month.
