Treasurer's Report

We have \$20,383.65 in the checking account after we moved \$5,000.00 to money market account. We've had \$6,270 paid in membership dues so far and a total of 44 members. We received a \$100 donation from the Legion for Fireworks, and \$194.93 from the Valley Home Companion Show.

We obtained a maintenance agreement estimate from Boise Office Equipment (BOE) for the Chamber Office copier (Xerox 7545 WorkCentre) that Midas donated to us. The \$55/monthly fee for servicing includes 1000 black and white copies, 200 color copies, toner, and any maintenance etc. (overall expense = \$660 annually). Without a maintenance agreement, a typical service call is \$150 + parts and a \$250 charge for toner cartridges. Pam motions to approve paying the monthly service fee that includes everything. Jason seconds. All in favor.

Julie is working on the 2020 ITC grant application. It is due April 1st, for pre-review by grant folks. Grant application presentations take place May 7th - May 8th. Application final closing date is May 29th. We are asking for letters of support and matching funds, for the grant.

By Laws

Patty approves all amendments made to the By Laws and motions to approve them. Jason seconds. All in favor. The amended By Laws have to be filed with the State. Julie's not sure how long that process takes and doesn't want to compromise the grant filing deadline; therefore, she will submit the existing By Laws (filed 6/13/2016) with the 2020 ITC grant application. Once By Laws amendments filed with the State, a copy will be forwarded for inclusion in the 2020 ITC grant application.
