Cascade Waterfall Project - Julie

This month, connected with Ashley Thompson (new pump location, water and power meter info, etc.) and Don Weber (pond liner, project lead, etc.). Still confirming electrician. Don arranged for delivery of the pond liner (\$502.80) and reported he has equipment to move rocks, etc. Recommend the chamber take on responsibility for the waterfall project, cover cost of liner (to reimburse Don), identify and pay an electrician to hook-up the new pump, and set up an account for future sponsorships/donated funds for ongoing maintenance, etc. **Brian motion that Chamber set up dedicated account for "Cascade Waterfall Project", seed account with \$1,000.00, and put Jenni and Brian on account. Barb second. All in favor. Motion passed.** Alison motion that chamber cover cost of pond liner (\$502.80) and pay electrician to connect the new pump. Brian second. All in favor. Motion passed. The Mayor confirmed City Public Works can incorporate pump winterization and Spring resumption in with Sports Park winterization and Spring resumption process. Discussion regarding sponsor campaign and recognition options (i.e. signage, etc.). Suggestion to place a donation bucket at Hog Wild event.
