## Proposed City of Cascade "Mobile Food Concessionaires" Ordinance -

On Jan 19th, AJ submitted a letter to City Council stating given the detailed and far reaching impact of the proposed ordinance, the Chamber requests that the City Council table final decision until Mar 1st to allow more time to collect input from membership.

Public Hearing at City Hall was held last night. Ordinance prioritizes "Health & Safety" with the belief that we need an ordinance to establish rules so the City has recourse to protect our community. Outcomes include: (1) City Council Tabled decision for now, 2) Steering Committee was created, Larry Morton is committee lead, 3) any comments/concerns, etc. need to be submitted in writing to City Clerk, <a href="mailto:clerk@cascadeid.us">clerk@cascadeid.us</a>.

General discussion among meeting attendees highlighted that social media is a primary driver for food trucks and for trucks to be successful a media frenzy needs to be created to draw foodies to Cascade; involved business owners need to remember to treat each other with mutual respect and kindness, promote and support each others businesses, and refer residents and visitor alike to all businesses to ensure overall community success.
